## GENERAL TERMS AND CONDITIONS

**Assumption of Risks:** Releases Exhibitor expressly assumes all risks associated with, resulting from or arising in connection with Exhibitor's participation or presence at the Event, including, without limitation, all risks of theft, loss, harm, damage or injury to the person (including death), property, business or profits of Exhibitor, whether caused by negligence, intentional act, accident, act of God or otherwise. Exhibitor has sole responsibility for its property or any theft, damage or other loss to such property (whether or not stored in any courtesy storage area, including without limitation any subrogation claims by its insurer). Neither Organizer nor the Exhibit Facility accepts responsibility, nor is a bailment created, for property delivered by or to Exhibitor.

**Assignment of Space Exhibit:** space shall be assigned by GSE in its sole discretion for the Event and for the Event Dates only. Any such assignment does not imply that similar space will be assigned for future events held by Organizer. GSE reserves the right to change the floor plan or to move an Exhibitor to another booth location prior to or during the Event if GSE in its sole discretion determines that to do so is in the best interest of the Event.

**Cancellation by Exhibitor Cancellation:** Cancellation must have the prior written consent of GSE, which consent shall be in GSE's absolute discretion. Exhibitors who cancel exhibit space more than 60 days prior to the opening day of the Event, will be refunded total due, less \$50.00. There will be no refunds for cancellations made less than 30 days prior to the opening day of the Event. Exhibitor payment will be required.

**Cancellation of the Event:** If GSE cancels the Event due to circumstances beyond the reasonable control of GSE (such as acts of God, acts of war, governmental emergency, labor strike or unavailability of the Exhibit Facility) GSE shall refund to each Exhibitor its exhibit space rental payment previously paid, minus a share of costs and expenses incurred, in full satisfaction of Organizer's liabilities to Exhibitor.

**Exhibit Space:** Occupancy Hours and dates for installing, occupying and dismantling exhibits shall be those expressly specified by GSE. If Exhibitor fails to install its display in its assigned space by one hour before show opens or leaves its space unattended during the Exhibit hours, GSE shall have the right to take possession of the space and no refund will be due to Exhibitor. All exhibits must be open for business during the Event hours. Exhibitor may not dismantle the display until the Event is officially closed by GSE. Exhibitors may not assign their display space to third parties without prior written approval from GSE.
